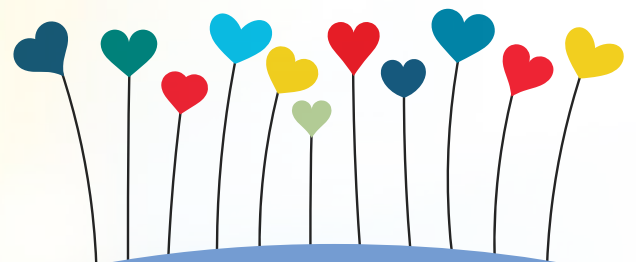


Anonymous Gift for Lobby and Floor Renovations
